- ▶ Serving in Andhra Pradesh, Karnataka, Maharashtra and Tamilnadu.

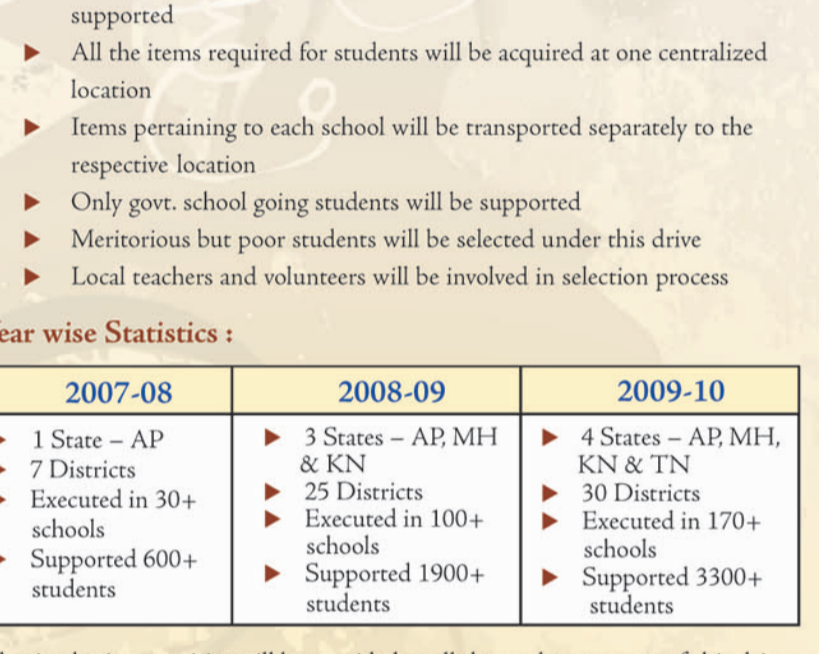
Spandana Model

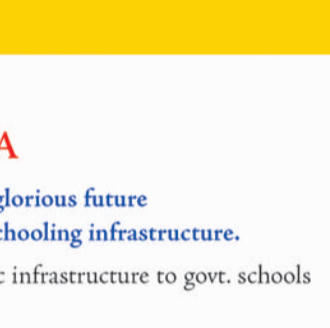

Pratibha project main objective is to support meritorious but poor students for their higher studies.



Main Features :

- ▶ Supports students till 10th class under Pratibha Annual Drive
- ▶ Supports students above 10th class under Pratibha appeals
- ▶ Organizing personality development and career training and seminars
- ▶ Organizing competitions like essay writing, Elocution , Painting, Quiz etc

Pratibha Annual Drive :

Pratibha Annual Drive is Spandana's **dynamic centralized model** to support school going meritorious but poor students on huge scale.

- ▶ Any student in any govt. school in any corner of the state could be supported
- ▶ All the items required for students will be acquired at one centralized location
- ▶ Items pertaining to each school will be transported separately to the respective location
- ▶ Only govt. school going students will be supported
- ▶ Meritorious but poor students will be selected under this drive
- ▶ Local teachers and volunteers will be involved in selection process

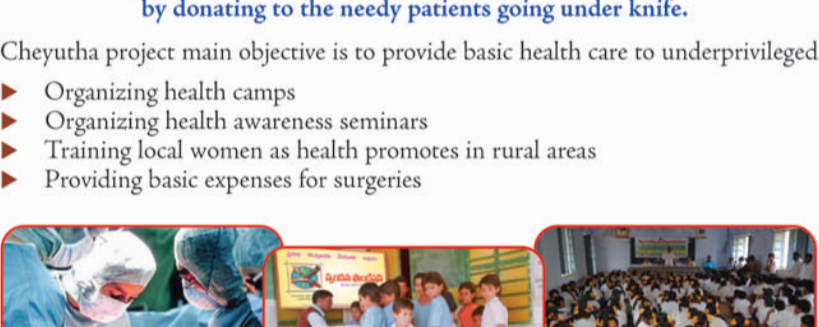

- ▶ Arranging additional teacher if required – Vidya Volunteer
- ▶ Creating better environment by providing drinking water, sanitation etc
- ▶ Providing learning / teaching materials to the school / college libraries



CHEYUTHA

Cheyutha project main objective is to provide basic health care to underprivileged.

- ▶ Organizing health camps
